BJP'S 'SAUGAT-E-MODI' EID KITS TO BENEFIT 32 LAKH MUSLIMS

Diary Times Desk: The BJP launched a nationwide outreach programme on Tuesday for economically weaker Muslim families ahead of Eid, a move seen as an effort to garner support from the community in the run-up to the Bihar Assembly polls scheduled for later this year.

The 'Saugat-e-Modi' campaign is expected to benefit 32 lakh underprivileged Muslims across the nation, who would receive special kits to celebrate Eid. It kicked off from Nizamuddin in southeast Delhi under the quidance of BJP chief JP Nadda.

Along with food items, the kits include clothes, vermicelli, dates, dry fruits and sugar. Women's kits will contain fabric for suits, while men's kits will include kurta-pyjamas. The cost of each kit will be around Rs 500 to Rs 600, as per a report by news agency ANI.

BJP Minority Morcha national president Jamal Siddiqui, who rolled out the initiative, said similar kits will be distributed among economically weaker members of other minority communities during their festivals under the 'Saugat-e-Modi' programme next month. Prime Minister Narendra Modi always says that he is the guardian of 140 crore Indians and he takes part in all festivals. He participates in Christmas, Easter, Baisakhi and sends 'chadar' for offering at Nizamuddin Dargah and Ajmer Sharif," he said. "So we decided that we will give kits with food to our brothers and sisters, who are poor. Each kit will also have clothes for our sisters," he told news agency PTI. As many as 32,000 Minority Morcha workers will contact 32,000 mosques.

Diary Times Desk: Freedom of expression cannot be used to mount "personal attacks", Uttar Pradesh Chief Minister Yogi Adityanath told news agency ANI in an exclusive interview to be aired Wednesday morning, referring to comedian Kunal Kamra and his 'gaddar' joke about Maharashtra Deputy Chief Minister Eknath Shinde.

"But unfortunately, some people think it is their birthright to use this freedom to tear the country apart and widen the division," the firebrand BJP leader said on the political row around Mr Kamra's remarks.

The comedian - who on Monday told Mumbai Police he did not regret making the joke and would only apologise if ordered to by the courts - has told NDTV he has since received 500 threatening calls.

In a show shot at the Habitat Comedy Club (now demolished by the Mumbai civic body over alleged building violations) in Mumbai's Khar, Mr Kamra played out a satirical version of a popular Bollywood song - 'bholi si surat' - from the 1997 blockbuster 'Dil To Pagal Hai'.

The satire referred to the word 'gaddar', or 'traitor', which was seen as a reference to Mr Shinde splitting the Shiv Sena in 2022 and joining hands with the BJP. This, in turn, led to the Uddhav Thackeray-led government losing power in Maharashtra. Meanwhile, Yogi Adityanath also unleashed multiple attacks on the Congress – from allegations it "used billionaire George Soros' money" to try and influence the 2024 Lok Sabha election" to calling the party's Karnataka government's four per cent Muslim quota bill an "insult to Babsaheb Ambedkar's Constitution". "They (the Congress-led INDIA opposition bloc) spread propaganda... they not only spread it, but foreign money was also involved. Soros long ago announced it..." he said.

INDIA MAY INTERFERE IN GENERAL ELECTION ON APRIL 28: CANADA

Diary Times Desk: China and India are likely to try to interfere in the Canadian general election on April 28, while Russia and Pakistan have the potential to do so, the country's spy service said on Monday. The Canadian Security Intelligence Service made its comments at a time when Ottawa's relations with both India and China are chilly. Beijing and New Delhi have denied previous allegations of interference. Canada was slow in responding to efforts by China and India to interfere in the 2019 and 2021 elections but their outcomes were unaffected by the meddling, an official probe said in a final report released in January. Vanessa Lloyd, deputy director of operations at CSIS, told a press conference that hostile state actors were increasingly leveraging artificial intelligence to meddle in elections. "The PRC (People's Republic of China) is highly likely to use AI enabled tools to attempt to interfere with Canada's democratic process in this current election," she said. Earlier this month Beijing announced tariffs on more than \$2.6 billion worth of Canadian agricultural and food products, retaliating against levies Ottawa slapped on Chinese electric vehicles and steel and aluminum products last year.



CASH AT JUDGE'S HOUSE: 3-JUDGE PANEL BEGINS INQUIRY; VISITS JUSTICE VARMA'S HOUSE

Diary Times Desk: The three-member inhouse committee appointed by Chief Justice of India Sanjiv Khanna on Tuesday commenced its inquiry into allegations of unaccounted cash at the residence of Justice Yashwant Varma - a sitting judge of the Delhi High Court -- during a fire on March 14. As a first step, the committee consisting of Punjab and Haryana High Court Chief Justice Sheel Nagu, Himachal Pradesh High Court Chief Justice GS Sandhawalia and Karnataka High Court judge Anu Sivaraman visited Justice Varma's official residence at 30, Tuahlak Crescent, for around 30-35 minutes, sources said. The committee was understood to have inspected the site this afternoon, they said, adding it was not clear if Justice Varma was at his residence during the committee's visit. If the three-judge committee indicts Justice Varma, the CJI can advise him to resign or to seek voluntary retirement. However, if the judge in question ignores his advice.

YUNUS' 4-DAY VISIT TO CHINA, MEETING WITH XI AND **GROWING CLOSENESS BETWEEN INDIA'S NEIGHBOURS**



Diary Times Desk: On Wednesday Bangladesh interim government's Chief Adviser Muhammad Yunus will leave for China where he will hold multiple engagements, including a bilateral meeting with Chinese President Xi Jinping. Bangladesh Sangbad Sangstha reported that Yunus will address the Boao Forum for Asia (BFA) conference, meet CEOs of giant global and Chinese companies, deliver a lecture at Peking University (PKU), visit hi-tech parks and hold talks with hospital chains to invite them to explore business potential in Bangladesh. The Yunus-Xi talks are expected to hover around boosting the economy and infrastructure in Bangladesh, including establishment of the Chinese Economic Zone in Chattogram, negotiations around the Bangladesh-China Free Trade Agreement (FTA) and Investment Treaty, signifying Beijing's deepening strategic and the economic engagement with administration in Dhaka, According to reports, China is also sending a chartered aircraft to bring Yunus to Beijing. The visit comes amid the not-sowarm relationship between Bangladesh and India since the ouster of former Bangladesh Prime Minister Sheikh Hasina following the violent student-led protests in August last.

KAMRA'S JIBE IS LIKE TAKING 'SUPARI' TO SPEAK AGAINST A **PERSON: EKNATH SHINDE**

Diary Times Desk: Maharashtra Deputy Chief Minister Eknath Shinde has likened comedian Kunal Kamra's jibe at him to taking "supari" (contract) to speak against someone, and said there should be a decorum while making a satire, otherwise the "action causes a reaction". SHIMLA AIRPORT: EQUIPMENT BROUGHT FROM DELHI, ENGINEERS REMAINED BUSY IN REPAIRING THE AIRCRAFT; DEMAND RAISED TO EXTEND THE RUNWAY

Diary Times Desk: Engineers were on duty all day on Tuesday to repair the technical fault in the aircraft at Jubbarhatti Airport in Shimla. To repair the technical fault, equipment was brought to Shimla by a plane from Delhi at around 10 am. After this, the engineers were busy repairing the aircraft till late evening. On the other hand, air services between Delhi-Shimla, Shimla-Dharamshala, Dharamshala-Shimla and Shimla-Delhi are likely to be restored from Wednesday. Engineers at Jubbarhatti Airport started repairing the technical fault in the aircraft from 9 am on Tuesday. During this, the engineers also took information about the fault from the pilot of the aircraft. The acting director of the airport was also present during this time. On Monday, a major accident was averted at Jubbarhatti Airport when the ATR-42 aircraft of Alliance Air, which came from Delhi to Shimla, was stopped with emergency brakes.

When the female teacher asked the students the meanings of words in the class, many children could not give the correct answer. Seeing this, the female teacher ordered her daughter to stand up.

BILASPUR FIRING INCIDENT: FIVE ARRESTED SO FAR IN BAMBER THAKUR FIRING CASE, SAURABH AND KULDEEP IN CUSTODY

Diary Times Desk: In the former MLA Bamber Thakur firing case, the police have detained Kuldeep alias Shishu and Saurabh Patial alias Fandi of Rohtak. It is being told that the SIT has caught both of them from Rohtak in Harvana. Both have been taken to Bilaspur, the police has not yet confirmed the arrest of both. Apart from this, two shooters are out of police custody. SP Bilaspur informed that one accused has been arrested in the firing case. Already four accused Manjeet Nadda, Ritesh Sharma, Rohit Rana and Sagar have been arrested and sent to judicial custody. On March 24, the police arrested Ajay Kumar (24) son of Prem Singh, resident of village Goyala Kalan, Tehsil Badli, District Jhajjar (Haryana). On Tuesday, the accused was produced in the court, from where orders were issued to send him to judicial custody till April 7. According to sources, the SIT team formed in the case has also detained two more accused Saurabh Patial and Kuldeep. Both have been brought to Bilaspur. Kuldeep alias Shishu was absconding since January in a case of Arms Act registered in Ghumarwin police station. Accused Kuldeep is from Rohtak in Haryana. Ghumarwin police had registered a case on January 8 that some youths were practicing shooting in the Jahri forest.

HIMACHAL NEWS: MEDICINES ARE BEING MADE IN OTHER STATES, BUT THEY ARE WRITING 'MADE IN HIMACHAL' ON THE TOP; AN ATTEMPT TO TARNISH THE IMAGE

LOK SABHA PASSES FINANCE BILL 2025, REMOVES 6% DIGITAL TAX ON ONLINE ADS

Diary Times Desk: The Lok Sabha on Tuesday approved the Finance Bill which included 35 government amendments, one of which eliminates the 6 percent digital tax on online advertisements. With this, the Lok Sabha has completed its part of the budget approval process, and the Rajya Sabha will now review the Bill. After the Rajya Sabha approves the Bill, the Budget process for 2025-26 will be complete. The Union Budget 2025-26 envisages expenditure of Rs 50.65 lakh crore, an increase of 7.4 per cent over the current fiscal. The total capital expenditure proposed for the next fiscal is Rs 11.22 lakh crore and an effective capital expenditure of Rs 15.48 lakh crore. It proposes a gross tax revenue collection of Rs 42.70 lakh crore and a gross borrowing of Rs 14.01 lakh crore. According to Budget documents, Rs 5,41,850.21 crore has been earmarked for Centrally Sponsored Schemes for the financial year starting April 1, 2025. This compares with Rs 4,15,356.25 crore for the current financial year.

INDIA OPEN TO TARIFF CUTS ON US IMPORTS WORTH \$23 BILLION: REPORT

Diary Times Desk: The government is open to cutting tariffs on more than half of US imports worth \$23 billion as part of a trade deal being negotiated between the two countries, news agency Reuters reported, citing two government sources. This would be one of the biggest tariff cuts in years, aimed at preventing reciprocal tariffs that could hurt exports. The government is trying to reduce the impact of US President Donald Trump's global reciprocal tariffs, which are set to take effect from April 2. These new tariffs have disrupted markets and created concerns among many countries, including some of the US's Western allies. According to an internal analysis by India, the new US tariffs could impact 87% of Indian exports to the US, which are worth around \$66 billion, two government officials told Reuters. To avoid this impact, India is open to lowering tariffs on 55% of US imports that are currently taxed between 5% and 30%, according to sources. Some could be reduced significantly, while others may be removed entirely. The proposal is still under discussion, and Indian government officials have not made a final decision. Other options being explored include adjusting tariffs for specific sectors instead of a broad tariff cut and negotiating reductions for selected products.

"KAAT DENGE TUMHE": KUNAL KAMRA HAS GOT 500 THREATENING CALLS, SAY SOURCES

The satirical song also had a mention of 'gaddar' (traitor) which was seen as a reference to Mr Shinde splitting the Shiv Sena in 2022 and joining hands with the BJP, leading to the Uddhav Thackeray-led government losing power in Maharashtra. After Mr Kamra's show was posted on YouTube, Shiv Sena workers had vandalised the Habitat Comedy Club in Khar.

SUPREME COURT TAKES NOTE OF ALLAHABAD HIGH COURT'S 'GRABBING

BREASTS NOT RAPE' ORDER

Diary Times Desk: The Supreme Court on Tuesday took note of the controversial ruling of the Allahabad High Court that grabbing breasts and breaking pyjama strings was not rape. The High Court's order came on March 17 in a case related to attempted rape of a minor. A Supreme Court bench of Justice BR Gavai and Justice Augustine George Masih will hear the matter on Wednesday. The Allahabad Court had said in its order that "the allegation of holding the victim's breasts and breaking the waistband of the pyjama did not constitute a case of attempted rape against the accused". The court remarked that it was an allegation of sexual assault. The judge, Justice Ram Manohar Narayan Mishra, who gave the order, said after recording the facts of the incident involving an 11-year-old girl, it was a case of assault on the dignity of a woman, but can't be called an attempt to rape. The High Court's verdict drew massive condemnation from various quarters.

ON MURKY DELHI JUDGE CASH-AT-HOME ROW, CENTRE CALLS ALL-PARTY MEET: SOURCES

Diary Times Desk: The centre on Tuesday reached out to all political parties on the issue of cash found at the home of a Delhi High Court judge -Justice Yashwant Varma. Sources said the centre wants to hear the views of all parties - whether part of the union government or not - on this sensitive issue. The all-party call came after Rajya Sabha Chairperson Jagdeep Dhankhar's meeting earlier today with the floor leaders of various parties, including the Congress, Bengal Chief Minister Mamata Banerjee's Trinamool, Tamil Nadu's ruling DMK, the BJD from Odisha, the BRS and YSRCP from Telangana and Andhra Pradesh, and the Uddhav Thackeray-led Shiv Sena faction. Union Law Minister Arjun Ram Meghwal also attended this meeting, after which floor leaders were told to discuss the issue with their respective parties ahead of another meeting. Meanwhile, centre will decide on its next steps after the allparty meet.

FOETUS, VESTIGIAL ORGANS DUMPED IN ROADSIDE GARBAGE IN PUNE, CASE REGISTERED

Diary Times Desk: Police on Tuesday registered a case against unidentified persons after a foetus and vestigial organs that were part of biomedical waste, were found dumped in glass containers at Daund in Maharashtra's Pune district, officials said. Ten glass containers containing this biomedical waste were found dumped in the garbage by the roadside in Daund in the morning, they said. "We found one foetus and some vestigial organs. All these were disposed of in 10 different glass containers in a wrongful manner at a garbage site located at the Borawake chowk in Daund," inspector Gopal Pawar of Daund police station said. An offence was then registered against unidentified persons under the Bharatiya Nyaya Sanhita (BNS) sections 89 (causing a miscarriage without the woman's consent), 90 (death caused by an act done with intent to cause miscarriage), 271 (negligently spreading a disease dangerous to life) and 272 (malignant act likely to spread infection of disease dangerous to life), he said.



CANADA CITES "INDIA'S GROWING GLOBAL INFLUENCE" IN ALLEGATION AGAINST PAK

Diary Times Desk: Canada on Monday said Pakistan could interfere in its April 28 general election to counter India's "growing global influence". Vanessa Lloyd, the deputy director of operations at the Canadian Security Intelligence Service (CSIS), said Islamabad could conduct foreign interference activities against Canada. "The government of Pakistan could potentially conduct foreign interference activities against Canada in line with its strategic aims to promote political, security and economic stability in Pakistan and to counter India's growing global influence," she told a press conference. Ms Lloyd also said that New Delhi could interfere in the election. "We have also seen that the government of India has the intent and capability to interfere in Canadian communities and democratic processes to assert its geopolitical influence," she said. Canada had levelled similar allegations against the two countries last year, a charge unequivocally rejected by New Delhi. The spy agency in April 2024 released an unclassified summary tabled as part of a federal inquiry examining potential foreign interference, alleging "clandestine" activities by both India and Pakistan during the 2021 and 2019 general elections.

HOW DONALD TRUMP IS INADVERTENTLY HELPING THE LIBERALS IN CANADA

Hamdan Ballal, co-director of the award-winning "No Other Land", was attending a gathering for Iftar, the end of the daily Ramadan fast, at Susiya village near Hebron, when a group of settlers attacked the gathering, said Jihad Nawajaa, head of the Susiya local council. "Dozens of settlers attacked the gathering at Iftar," Nawajaa told Reuters by phone. The young men came out to prevent them, and there were about eight injuries on our side." Israeli police arrested three men, including Ballal, who was injured during the standoff, he said. It was unclear how badly he had been injured. The Israeli military said police and soldiers intervened after Palestinians threw rocks at the vehicles of Israeli citizens. It said three Palestinians suspected of throwing rocks at them were arrested.

SIXTH NIGHT OF PROTESTS IN TURKEY AS ERDOGAN HITS OUT AT UNREST

Diary Times Desk: Turkey's President Recep Tayyip Erdogan has blamed opposition parties for provoking a "movement of violence" as protests in the country continued for a sixth night. Unrest began in Istanbul last Wednesday when the city's Mayor Ekrem Imamoglu - Erdogan's main political rival - was detained on corruption charges. Imamoglu said the allegations against him were politically motivated, a claim Erdogan has denied. Turkey's main opposition party, the Republican People's Party's (CHP), which announced Imamoglu as its presidential candidate on Sunday, said the demonstrations will end on Tuesday, without saying what the next steps would be. Erdogan has labelled the demonstrations "evil" and blamed the opposition for "disturbing the peace of our citizens with provocations". Speaking from Ankara, Turkey's capital, Erdogan called.

COLUMBIA STUDENT PROTESTER SUES TRUMP TO STOP DEPORTATION

Diary Times Desk: A Columbia University student who moved to the US as a child is suing the Trump administration over attempts to deport her for participating in pro-Palestinian protests. Yunseo Chung, 21, a legal permanent US resident who moved from South Korea when she was seven, alleges immigration officials have executed search warrants at multiple Columbia facilities, including her dormitory. The lawsuit seeks to block her detention and deportation, citing First Amendment and other constitutional rights. It follows the administration's recent detention of Mahmoud Khalil, a prominent pro-Palestinian activist, who helped negotiate between university officials and student protesters. Ms Chung's lawyers have said she participated in campus protests against Israel's war in Gaza, but had not made statements to the press or taken on a high-profile role like Mr Khalil. The Department of Homeland Security claims Ms Chung engaged in "concerning conduct", including her arrest at nearby Barnard College demonstration over student expulsions linked to pro-Palestinian protests, US media report.



MAGNITUDE 6.8 EARTHQUAKE HITS NEW ZEALAND'S RIVERTON COAST

Diary Times Desk : A massive earthquake of magnitude 6.8 sent tremors off the coast of Riverton in New Zealand on Tuesday, said the United States Geological Survey. The quake, which initially was recorded at 7 magnitude, struck at a depth of 10 kilometres (6.2 miles) off the southwest tip of the South Island, the USGS said. So far, no tsunami warning has been issued for the region. As per the USGS website, there have been green alerts for shaking-related fatalities and economic losses, as per which it has concluded that there are low chances of casualties and damage. Further, it said that the population residing in the quake-hit region live in structures that are highly resistant to earthquakes, with an exception of some vulnerable structures. Meanwhile, New Zealand's emergency management agency said that it was "assessing whether the earthquake has created a tsunami that could affect" the country. In a national advisory, the agency said, "If a tsunami has been generated in this location it is not likely to arrive in New Zealand for at least one hour."

'CONSIDERED LETTING HIM DIE PEACEFULLY': MEDICAL HEALTH TEAM ON POPE FRANCIS

Diary Times Desk: Pope Francis came so close to death at one point during his fight in hospital against pneumonia that his considered ending treatment so that the 88-year-old pontiff could die peacefully, the head of the pope's medical team said on Tuesday. After a breathing crisis on February 28 that involved Francis nearly choking on his vomit, "there was a real risk he might not make it," said Sergio Alfieri, a physician at Rome's Gemelli hospital. "We had to choose if we would stop there and let him go, or to go forward and push it with all the drugs and therapies possible, running the highest risk of damaging his other organs," Alfieri told Italy's Corriere della Sera.

HIGH COURT DIRECTS PUNJAB TO PROVIDE FIR DATA ON THREAT FROM 'GANGSTERS'

Diary Times Desk: The Punjab and Haryana High Court has directed Punjab to provide details regarding the number of FIRs registered across the state based on complaints by individuals alleging threat perceptions from 'gangsters.' The state has also been asked to furnish information about any specialised anti-gangster task force constituted for dealing with such cases. The direction by Justice Harkesh Manuja of the high court came on a contempt petition filed against Additional Director-General of Police (Security) Sudhanshu S Srivastava by Simarjit Singh through counsel Onkar Singh Batalvi. Taking up the matter, Justice Manuja called for an affidavit detailing these aspects. The court also sought information on the present status of the Punjab Control of Organised Crime Act and the steps taken to expedite investigations in cases registered under it. Justice Manuja also granted the government time to clarify whether any separate legislation had been enacted in Punjab specifically addressing organised crime. "Counsel for the respondent prays for time to apprise this court as to whether any separate legislation has been promulgated by the Government of Punjab in relation to the organised crimes," the bench observed, while fixing the case for April 3.



LIQUOR VENDS' TENDERING IN CHANDIGARH UNDER SCANNER AMIDST CARTELISATION ALLEGATIONS

Diary Times Desk: The tendering process of liquor vends in Chandigarh for 2025-26 today came under judicial scanner, with a contractor alleging cartelisation and noncompliance with the excise policy. In a petition filed before the Punjab and Haryana High Court, the petitioner-contractor has, among other things, contended that over 87 out of 97 liquor vends have been allocated to just two or three individuals operating under different firm names or through their relatives, associates, and employees. Challenging the notice inviting tender (NIT) dated March 13, M/S Kler Wines and another petitioner through counsel Bikramjit Singh Patwalia contended that the entire process was carried out in contravention of the prescribed rules. Seeking the quashing of the NIT, he added that the flawed process was also in violation of the Excise Policy 2025-26 as well as the Punjab Liquor Licence (Chandigarh Amendment) Rules, 2020.

AFTER STUDENT'S DEATH, EXPERTS CALL FOR COLLECTIVE EFFORTS ON SENSITISING YOUTH TO SOCIAL MEDIA USE

Diary Times Desk: The death of a 17-yearold student by suicide has once again called for collective efforts from school authorities and parents on sensitising the youth to the proper use of social media platforms. The victim, a Class XI student of Government Senior Secondary School, Sector 21, was accused of using social media against his teachers. Despite awareness efforts, the youth are finding the social media a better way to discuss their problems or to give vent to their anger, claimed local teachers. According to sources, a majority of the local schools are facing the problem of fake social media accounts being used by students to make accusations against teachers as well as school authorities. HC ISSUES NOTICE TO CM BHAGWANT MANN

Diary Times Desk: Acting on a petition filed by Emaan Singh Mann - former MP Simranjit Singh Mann's son the Punjab and Haryana High Court has put Punjab Chief Minister Bhagwant Singh Mann and another respondent on notice. He had moved the court following the dismissal of his complaint alleging defamation. "Despite having proved prime facie case of defamation, the criminal complaint has been dismissed without summoning the respondent/accused," Mann contended through counsel Abhaypal Singh Gill and Bhagoti Singh. Appearing before Justice Tribhuvan Dahiya's Bench, the counsel contended that the petitioner, prima facie, established before the Magistrate that he did not own 125 acres said to have been encroached upon by him. "Besides, the impugned order refers to a report said to have been prepared by the officials and read by the accused, whereas it is not a part of the record," he added. Taking up the matter, the Bench also fixed the case for further hearing on May 3.

GOVERNOR'S ADDRESS A BUNDLE OF LIES: PUNJAB LOP PARTAP SINGH BAJWA

Diary Times Desk: Acrimonious scenes were witnessed during a debate on the Governor's Address as the Opposition teared into the government's claim in absence of Chief Minister Bhagwant Mann. Terming the Governor's Address as a "bundle of lies", Leader of the Opposition Partap Singh Bajwa accused the CM of running away from the discussion. He said AAP, which had come to power by promising 'badlav', had fallen flat in its actions. He added that neither kisan nor jawan was safe under AAP. "The introduction of the digital marking system is aimed at possibility preventing the tampering with answer sheets and speeding up the evaluation process to ensure timely declaration of results. A tender has been floated to hire a private agency to design.

TWO ARRESTED IN CONNECTION WITH ATTEMPTED MURDER OF MANDI DHABA OWNER

Diary Times Desk : In a breakthrough development in the case of an attempted murder, two suspects have been arrested in connection with the attack on Pradeep Guleria, a 61year-old owner of a dhaba in Dayadi village in Mandi district. The incident occurred on March 21 at the Royal Lass Kitchen near Pulaharat. The suspects. identified as Mohammad Azmal (25) and his brother Azam (19), both residents of Muzaffarnagar, Pradesh, Uttar were apprehended late on the night of March 24, following a swift investigation by local police. According to Mandi SP Sakshi Verma, the attack was severe and prompted the formation of a Special Investigation Team (SIT) led by the Additional Superintendent of Police (LR), with four other alona investigative teams. Their efforts led to the identification of the two suspects, who had been residing as tenants in the Dangu village, under Balh tehsil in Mandi, for an extended period. Both individuals were employed in Mandi as aluminium fitters. The SP confirmed that the weapon used in the attack has been recovered from the possession of the arrested individuals.

KANGRA POLICE ARRESTS DRUG PEDDLER UNDER PIT NDPS ACT

JOIN REMOTE POSTINGS OR FACE DISCIPLINARY ACTION: HIMACHAL HEALTH MINISTER WARNS DOCTORS

Diary Times Desk: Himachal Pradesh Health and Family Welfare Minister Dhani Ram Shandil has warned doctors and medical staff that they must join their postings in remote and difficult areas or face disciplinary action. The minister issued this warning while responding to a cut motion on the Health Department in the Vidhan Sabha. "I would like to make it amply clear that action will be taken against doctors who refuse to obey the transfer orders to remote rural areas, which are facing significant vacancy problems," Shandil said. They will have to join their postings, even if it's for a stipulated period, or face action, he added. The minister explained that the burden on referral institutions will only decrease when health facilities in rural and far-flung areas are strengthened. He assured that efforts are being made to improve healthcare quality, recruit specialists and MBBS doctors, and reduce vacancies. Shandil also announced several initiatives, including the introduction of robotic surgery at the Tanda medical college and Chamiana super-specialty hospital in Shimla. The state government has allocated Rs 300 crore to strengthen health facilities at medical colleges in Chamba and Hamirpur, and Rs 85 crore to set up a Cancer Centre at Hamirpur.



BUMBER-JAMWAL RIFT GETS UGLY, BILASPUR LEADERS TRADE ACCUSATIONS OUTSIDE VIDHAN SABHA

Recently, MS Dhoni also commented on the impact of the rule and said that high-scoring games have been happening more due to the conditions and comfort of the players. "When this rule was implemented, I felt it wasn't really needed at that time. In a way, it helps me, but at the same time, it doesn't. I still do my wicket keeping, so I'm not an impact player. I have to be involved in the game. A lot of people say the rule has led to more high-scoring games. I believe it's more due to the conditions and the comfort level of players. The number of runs being scored isn't just because of an extra batsman.
