RAHUL GANDHI ON DONALD TRUMP'S TARIFFS: 'WILL COMPLETELY DEVASTATE INDIAN ECONOMY'

Diary Times Desk : Leader of Opposition in the Lok Sabha Rahul Gandhi on Thursday said that the reciprocal tariffs or import duties imposed by US President Donald Trump will "completely devastate" the Indian economy.

He also claimed that China had taken over 4,000 square kilometres of Indian territory and demanded answers from the government over these issues. "Our ally has suddenly decided to impose a 26 per cent tariff, which is going to completely devastate our economy – our auto industry, pharmaceutical industry, and agriculture are all in line," Rahul Gandhi said.

"...What are you doing about our land, and what will you do about the tariff our ally has imposed on us?" Donald Trump on Wednesday announced new reciprocal tariffs on several countries, including India, saying that the US has been "looted, pillaged, raped, plundered" by other nations.

While the US announcement lists 26% as the tariff levied on India, other documents, including those received by the ministry, show that the rate is actually 27%. The Indian government has said that it is carefully examining the implications of Trump's announcement. The commerce ministry said it was engaged with all stakeholders, including Indian industry and exporters, taking feedback on their assessment of the tariffs and assessing the situation keeping in view the vision of a developed India. Speaking during the Zero Hour in the Lok Sabha on Thursday, Gandhi criticised the Narendra Modi-led government over the celebration of the 75th anniversary of diplomatic ties between India and China.

Diary Times Desk : Retirement fund body EPFO on Thursday said applicants seeking withdrawal from provident funds online do not have to upload the image of a cancelled cheque and their bank accounts need not be verified by employers.

The move is expected to fast-track claim settlement process for nearly eight crore members and ensure ease of doing business for employers. At present, members of Employees' Provident Fund Organisation (EPFO), while applying for withdrawal of funds from PF accounts online, need to upload image of cheque leaf or attested photo copy of the passbook of the bank account seeded with the UAN (Universal Account Number) or PF number. The employers are also required to approve the bank account details of the applicant.

The EPFO has completely dispensed with the requirement of uploading an image of a cheque leaf or attested bank passbook while filing online claims, the labour ministry said in a statement. These two steps have been done away with to ensure 'ease of living' for EPF members and 'ease of doing business' for employers. These measures will significantly streamline the process of claim settlement and reduce grievances related to claim rejections, it stated.

These requirement were initially relaxed on a pilot basis for certain KYCupdated members. Since the pilot launch on May 28, 2024, the move has already benefited 1.7 crore EPF members. Following the successful pilot, EPFO has now extended this relaxation to all members, the ministry said. Since the bank account is already verified along with the EPF members' details at the time of seeding of bank accounts with the UAN, this additional documentation is no longer necessary, it said, adding, this will eliminate the possibility of claim rejections due to poor-quality/unreadable uploads and reduce associated grievances.





'UNCONSTITUTIONAL, AIMED AT TARGETING MUSLIMS': **OPPOSITION SLAMS WAQF BILL IN RAJYA SABHA**

Diary Times Desk : INDIA bloc parties on Thursday opposed the Waqf Amendment Bill in the Rajya Sabha, alleging that it was "unconstitutional" and aimed at targeting Muslims. Leaders of several opposition parties, including the Congress, TMC, DMK, AAP, Shiv Sena (UBT), Samajwadi Party, RJD, and Left parties also alleged that the Bill was brought by the government with mala fide intentions. Leader of the House and BJP leader JP Nadda, however, said the Bill is not against Muslims and claimed that it is aimed at helping the poor and protecting the rights of Muslim women. Nadda also accused the Congress of making Muslim women second-grade citizens during its rule, and said the Modi government brought Muslim women into the mainstream by banning the practice of triple talaq. "We believe in real service, not in lip service...I stand in support of the (Waqf) Bill as its sole purpose is to bring reforms in managing the Waqf properties," Nadda said, emphasising that the current amendment in the Bill tries to bring accountability.



GOVERNMENT IS EYEING WAQF LAND, MAY TURN TO TEMPLE TRUST **PROPERTIES NEXT: UDDHAV**

Diary Times Desk: Shiv Sena (UBT) chief Uddhav Thackeray on Thursday claimed that the Union government has its eye on the land of the Waqf boards, and it may turn its attention to the land of temples, churches and gurdwaras next. His party opposed the BJP's stand on the Waaf (Amendment) Bill and "its ploy to take away (Waqf) land and give it to its industrialist friends," Thackeray said at a press conference here, hours after the bill was passed by the Lok Sabha. The Sena (UBT), a former BJP ally now part of the Opposition's INDIA grouping, has opposed the bill. Maharashtra Deputy Chief Minister Eknath Shinde, who heads the rival Shiv Sena, said by opposing the bill Thackeray committed a greater "crime" than by joining hands with the Congress. "The concern about the Muslim community shown by the BJP and its allies supporting the bill will put (Pakistan founder Muhammad Ali) Jinnah to shame," Thackeray told reporters. His remarks came as the BJP and the Shiv Sena led by Shinde.

RAHUL GANDHI SLAMS GOVT OVER 'CHINA OCCUPYING LAND', ANURAG THAKUR SAYS 'NOT A SINGLE INCH LOST'



Diary Times Desk : Leader of Opposition Rahul Gandhi on Thursday claimed that China had taken over 4,000 square kilometre of Indian territory and that reciprocal tariffs or import duties imposed by the US would "completely devastate" the Indian economy, as he demanded answers from the government over these issues. The BJP hit back at Gandhi over his remarks during the Zero Hour in the Lok Sabha, saying "not an inch of land" had been given to China under BJP rule and it was under Congress rule that China had occupied Indian territory. The ruling party also said it is the country's good fortune that the PM of this country is Narendra Modi before whom the world bows. Speaking during the Zero Hour, Gandhi slammed the government over the celebration of the 75th anniversary of diplomatic ties by India and China. "China is sitting on 4,000 square kilometre of our territory. I was shocked some time back to see that our foreign secretary (Vikram Misri) was cutting a cake with the Chinese ambassador. The question is -- what exactly is happening to this territory of 4,000 sq km that China has taken?" the former Congress president said.

PM MODI, MUHAMMAD YUNUS SEATED TOGETHER AT **BIMSTEC DINNER**

Modi is likely to meet Yunus on Friday on the sidelines of the sixth summit of the leaders of the Bay of Bengal Initiative for Multi-Sectoral Technical and Economic Cooperation (BIMSTEC). Since the interim government headed by Yunus stepped in following the ouster of the then prime minister Sheikh Hasina in August 2024, the ties between India and Bangladesh have seen a slump amid Delhi's concerns over the violence targeting Hindus and a rise of hardline Islamist forces there. The next hearing in this case will be on April 10. The Advocate General said that the technoeconomic feasibility report has been submitted by the government on March 30. The division bench had ordered the state government to submit a revised report to the Airports Authority of India within 10 days in its previous order. The work of expansion of Gaggal Airport has been decided to be done in two phases. The advocate of the petitioners said that according to the technical report, this area is sensitive from the earthquake point of view.

They said that the shops that were burnt to ashes in the fire were built on government land. Till now, no relief money has been provided to the affected people by the administration. Investigation is also being done as to how the shops caught fire. Tehsildar Dharwala Roop Singh Negi said that shops and jeeps have been burnt due to fire in Luna.

Lecturers have been appointed in English, Economics, Chemistry, Biology, Commerce, Political Science, History and Mathematics. These candidates who passed the recruitment examination of the State Public Service Commission have been given appointments in schools by the Directorate of Higher Education.

BENGALURU WEATHER FORECAST: CITY BRACES FOR HEAVY RAINFALL AS IMD ISSUES YELLOW ALERT

Diary Times Desk : Bengaluru residents can expect heavy rainfall, thunderstorms, and lightning on April 3, 2025, as the India Meteorological Department (IMD) has issued a vellow alert for the city. Temperatures are predicted to drop by 3 to 4 degrees Celsius, accompanied by gusty winds. The rainfall is attributed to a cyclonic circulation in the Bay of Bengal, which has intensified into a depression off the coast of Odisha. The Karnataka State Natural Disaster Monitoring Centre (KSNDMC) forecasts continued cloudy weather, thunderstorms, and moderate to heavy rainfall across several regions of Karnataka over the next five days. An orange alert has been issued for numerous districts in North Interior Karnataka. warning of thunderstorms, lightning, and gusty winds. According to a press release issued by the India Meteorological Department (IMD), this trend of sporadic rainfall is expected to continue. Chikkamagaluru and Hassan's maximum temperatures were nearly 7.5 degrees and 6 degrees below normal, respectively.

"MANIPUR FACING SEVERE CHALLENGES FROM ILLEGAL IMMIGRATION": SHASHI THAROOR

Diary Times Desk : After the Lok Sabha confirmed the imposition of President's rule in Manipur, Congress leader Shashi Tharoor on Thursday said he hopes peace and normalcy will be restored in the border state soon. "The Manipur discussion was essentially to approve the proclamation of the President's rule and that happened peacefully fundamental without any disagreement... Let us hope that peace and normalcy will be restored," Mr Tharoor said. Earlier, Union Home Minister Amit Shah moved the resolution for the Lok Sabha's clearance for President's rule in the state where ethnic violence began nearly two years ago. Mr Tharoor asked the house why it took up the Manipur issue at 2 am. "The biggest crisis we are facing today is that there has been an erosion of public trust in the State, the State of India, the state of Manipur and its institutions. And that legitimacy has to be regained during this period of President's rule," Mr Tharoor said. "On top of that we are seeing the state facing severe challenges from illegal immigration and drug trafficking, exacerbating the social and economic conditions I have mentioned," the MP said.

"BASED ON CONSCIENCE": NAVEEN PATNAIK'S PARTY EASES OPPOSITION TO WAQF BILL



Diary Times Desk : Naveen Patnaik's Biju Janata Dal has apparently had a change of heart about the Waqf Amendment Bill. After categorically saying it was against the bill ahead of its presentation in the Lok Sabha, the party, shortly before the voting in the Upper House, has tweaked its stand. In a post on social media platform X, formerly Twitter, senior party leader Sasmit Patra announced that there would be no party whip this time. "The Biju Janata Dal has always upheld the principles of secularism and inclusivity, ensuring the rights of all communities. We deeply respect the diverse sentiments expressed by different sections of the Minority communities regarding the Waaf (Amendment) Bill, 2024," his post read. "Our Party, having taken these views into careful consideration, has entrusted our Hon'ble Members in the Rajya Sabha with the responsibility of exercising their conscience in the best interest of justice, harmony and the rights of all communities, should the Bill come up for voting. There is no Party Whip," he added.

US MAN ARRESTED FOR ENTERING RESTRICTED NORTH SENTINEL ISLAND IN ANDAMANS: COPS

Diary Times Desk: A US national was arrested in Andaman and Nicobar Islands for allegedly entering the prohibited tribal reserve area of the North Sentinel Island, police said on Wednesday. Mykhailo Viktorovych Polyakov (24), arrested by the CID on March 31, had allegedly entered the North Sentinel Island without any authorisation, they said. He arrived in Port Blair on March 26 and ventured to North Sentinel Island from the Kurma Dera beach, they said. He launched his boat from Kurma Dera beach around 1 am on March 29, carrying a coconut and a can of cola as "offerings for the Sentinelese", police said. Polyakov reached the northeastern shore of North Sentinel Island by 10 am. Using binoculars, he surveyed the area but saw no inhabitants, they said. He remained offshore for an hour, blowing a whistle to attract attention, but received no response. He landed briefly for about five minutes, left the offerings on the shore, collected sand samples, and recorded a video before returning to his boat, police said.

BRS IT CELL BOOKED FOR SPREADING FAKE NEWS ON HYDERABAD UNIVERSITY LAND ROW

Diary Times Desk : The Cyberabad police have registered an FIR against members of the Bharat Rashtra Samithi (BRS) IT Cell for allegedly spreading misleading content about Hyderabad Central University land, aiming to provoke public unrest. According to the FIR filed at Gachibowli Police Station, the complaint was lodged by Bagannagari Arundawaj Reddy, a resident of Serilingampally. He alleged that BRS IT Cell members, including incharges Kontam Dileep and DR Krishank, used the party's official Instagram handle to alter photos and videos with unverified information about Hyderabad Central University land. These manipulated posts were allegedly circulated on various social media platforms to incite students and protestors. The complaint, filed on April 2, 2025, at 8.30 pm, states that the petitioner discovered the fabricated content earlier that day at 2 pm. As evidence, he provided ten attested copies of posts from the BRS's.

RAHUL GANDHI RAKES UP TARIFFS, CHINA BORDER ROW IN LOK SABHA, GETS BJP REBUTTAL

Diary Times Desk: Leader of the Opposition in the Lok Sabha, Rahul Gandhi, went on a warpath against the Centre over the border row with China and the imposition of steep tariffs by the US in Parliament, inviting a rebuttal from the BJP's Anurag Thakur. Speaking in the Lok Sabha on Thursday, Rahul said bowing its head before foreigners was in the BJP's history and culture. "Somebody once asked Indira Gandhi ji - 'In the matter of foreign policy, you lean left, or you lean right?' Indira Gandhi answered, 'I don't lean left or right, I stand straight'," Rahul said. "The BJP and the RSS have a different philosophy. When they are asked whether they lean left or right, they say we bow our head in front of every foreigner that comes in front of us. This is something that is in their culture, in their history," he further said. Referring to the India-China border issue, the Raebareli MP claimed that Beijing was now "sitting on over 4,000 sq km of our territory" and sought the status quo. "20 jawans attained martyrdom in 2020.

"IF YOU FIND MONEY AT JUDGE'S HOME...": MAMATA BANERJEE AFTER COURT SETBACK

Diary Times Desk: Hours after her government faced a big setback in the teachers' recruitment case, West Bengal Chief Minister Mamata Banerjee said she does not accept the Supreme Court judgment personally, but her government will implement it and repeat the selection process. She also questioned if Opposition BJP and CPM wanted Bengal's education system to collapse. As a citizen of this country, I have every right, and I cannot accept this judgment, with due respect to the judges. I am expressing my opinion from a humanitarian perspective. Don't misinform or create confusion," she told the media this afternoon. The government, she said, accepts the ruling and has already asked the School Service Commission to repeat the recruitment process. The Supreme Court today upheld the Calcutta High Court order, cancelling the appointment of more than 25,000 teachers and non-teaching staff under the West Bengal School Service Commission. The Supreme Court said the entire selection process is "vitiated by manipulation and fraud" and its credibility and legitimacy "denuded".

CHINA OPPOSES TRUMP'S **RECIPROCAL TARIFFS, VOWS** "COUNTERMEASURES"

Diary Times Desk : China on Thursday said it "firmly opposes" sweeping new US tariffs on its exports and vowed "countermeasures to safeguard its own rights and interests". US President Donald Trump has ignited a potentially ruinous global trade war after imposing 10 percent levies on imports from around the world and harsh extra duties on key trading partners. The Commerce Ministry in Beijing said in a statement that those tariffs "do not comply with international trade rules and seriously harm the legitimate rights and interests of the relevant parties". It urged Washington to "immediately cancel" them, warning they "endanger global economic development", hurting US interests and international supply chains. It also accused the United States of a "typical unilateral bullying practice". Trump unveiled particularly stinging tariffs of 34 percent on China, one of its largest trading partners, while a 10 percent base tariff on all countries will also apply to China. That comes on top of a 20 percent rate imposed last month. Beijing responded to those tariffs with levies of up to 15 percent on a range of US agricultural goods including soybeans, pork and chicken

INDIAN GETS 35-YEAR JAIL TERM FOR EXPLOITING MINORS IN US. **CHILD PORNOGRAPHY**

Diary Times Desk : A 31-year-old Indian has been jailed in US for sexually harassing several children through a social media app. Authorities said the man used to pose as a teenager to gain trust of children on the app and would then threaten and extort them with child pornography when they refused his requests. Sai Kumar Kurremula, 31, an Indian national living in Edmond, Oklahoma has been sentenced to 35 years in jail. Kurremula had been living on an immigrant visa. US Attorney Robert Troester in a statement said, "He has been sentenced to serve 420 months in federal prison for the sexual exploitation of three transportation of child children and pornography." After serving his term in a federal prison, he will also have to undergo a lifetime term of supervised release. In announcing his sentence, US District Judge Charles Goodwin noted that these offences are among those that society considers the most serious because they involve such vulnerable.

"I AM FREE": MYANMAR TEACHER **PULLED OUT OF RUBBLE 5 DAYS AFTER** EARTHOUAKE

Diary Times Desk: Entombed under his hotel bed for five days in the debris, two things enabled teacher Tin Maung Htwe to survive Myanmar's devastating earthquake: old school lessons and his own urine. The primary school headmaster was on a training course in Sagaing, the closest place to the epicentre, when the 7.7-magnitude earthquake struck. The 47-yearold remembered a decades-old school lesson to shelter under a bed if the world starts to shake. "As soon as I went under the bed, the whole hotel fell down and was blocked. All I could afford was to sav 'save me'," he said. "I was shouting 'save me, save me'." The Swal Taw Nann guesthouse where he was staying was reduced to a pile of bricks and twisted metal strips, the broken shell of its top storey resting on the remains of those below.

WHO FACES 2.5 BILLION DOLLAR FUNDING GAP AFTER US' WITHDRAWAL

Diary Times Desk : The World Health Organization (WHO) is facing a budget gap of 1.9 billion dollar for 2026 and 2027, along with a 600-million-dollar deficit through 2025, according to media reports. The 1.9-billion-dollar funding gap accounts for nearly 45 per cent of its already slashed budget for the twoyear period until 2027, Health Policy Watch, a non-profit independent global health news outlet, reported on Wednesday. The report, citing WHO officials at a Tuesday meeting, said the United States owes WHO 260 million dollars in dues for 2024 and 2025. Raul Thomas, WHO's assistant director general of business operations, revealed at the meeting that the outgoing administration of US President Joe Biden never paid the US 2024 dues of 130 million dollars owed before leaving office, reports Xinhua news agency, citing the Health Policy Watch report. Speaking to WHO staff via Zoom at the meeting, Director General Tedros Adhanom Ghebreyesus forecasted staff reductions.



US EMBASSY IN ROMANIA ANNOUNCES UPDATED VISA REOUIREMENTS AFTER SUSPENSION DECISION

Diary Times Desk : The United States Embassy in Bucharest has announced an update to visa requirements for Romanian citizens wishing to travel to the US, following president Donald Trump's decision to suspend Romania's entry into the Visa Waiver Program. According to the announcement, starting April 7, 2025, all temporary visa applicants must present a printed copy of the confirmation page with the barcode to demonstrate that they used the same DS-160 application form to schedule their interview. Moreover, before the interview, applicants must verify that they have completed and submitted the online DS-160 form and ensure that the barcode number on the DS-160 confirmation page matches the one used for scheduling the interview. "If the numbers do not match, applicants who scheduled their interview using an incomplete or incorrect form will not be allowed to proceed with the interview and will be required to reschedule their appointment through USTraveldocs.com/ro/, using the correct DS-160 barcode number.

RUSSIAN WOMAN WHO ASKED SOLDIER HUSBAND TO RAPE UKRAINIAN WOMEN JAILED

Diary Times Desk: A Russian woman has been sentenced to prison after urging her husband, a Russian soldier, to rape Ukrainian women during the ongoing war, according to Russian newspaper Pravda. The sentence comes amid the ongoing Russia-Ukraine conflict, which has been marked by widespread atrocities, including death, destruction, and numerous war crimes. The woman's actions have drawn significant attention as part of the broader human rights violations taking place in the region. The newspaper reported, quoting Radio Liberty, that Olga Bykovskaya, a Russian citizen who urged her husband, a Russian soldier, to rape Ukrainian women, has been convicted in absentia of violating the laws and customs of war and sentenced to five years in prison by the Shevchenkivskyi District Court of Kyiv. In April 2022, the Security Service of Ukraine (SSU) released audio of an intercepted conversation between a Russian soldier and his wife. The woman gave her husband permission to rape Ukrainian women as long as he "uses protection". Journalists from the Ukrainian and Russian services of Radio Liberty identified the couple as Olga and Roman Bykovsky.

5 OIL TANKER BOGIES DERAIL NEAR LALRU, TRAINS DELAYED ON AMBALA-CHANDIGARH STRETCH

Diary Times Desk : Several trains on the Ambala-Chandigarh route are running behind schedule after five oil tanker bogies derailed near the Lalru railway station earlier today around 2 pm. To avoid this stretch, a few trains have been diverted, according to the railway authorities. A major mishap was narrowly averted since the tankers were transporting inflammable liquid to an oil depot in Lalru. As a precautionary measure, fire tenders were deployed at the scene, and repair work began after a delay of about two hours. "Efforts are underway to restore the track, but it may take several more hours before traffic resumes," railway authorities said. A team of railway officials from Patiala rushed to the site to remove the derailed bogies from the Ambala-Chandigarh upline and restore train movement. "No technical fault or negligence has been detected so far, but a detailed inquiry will be conducted soon," they added.

CHANDIGARH POLICE TO INVESTIGATE COL BATH ASSAULT CASE; PUNJAB POLICE EXCLUDED FROM INQUIRY

Diary Times Desk : Acting on Colonel Pushpinder Singh Bath's petition seeking transfer of the assault case probe to the CBI or an independent agency, the Punjab and Haryana High Court on Thursday handed over the investigation to the Chandigarh Police. Justice Harpreet Singh Brar made it clear in the open court that an officer from the Punjab Police cadre would not be involved in the investigation. The court, at the onset asked, the State of Puniab to specify whether it wanted a consent-based order or one on merit. The Bench also asked it to specify whether handing over the probe to the Chandigarh Police was acceptable before the order was passed. The State of Punjab was represented by senior advocate Randeep Singh Rai. The case was initially placed before Sandeep Moudgil's Bench, which had questioned the State on the nonarrest of the accused police officers despite the registration of an attempt to murder case against them.

PUNJAB COMPLETES ALLOTMENT PROCESS FOR 207 RETAIL EXCISE GROUPS

Diary Times Desk : Punjab Finance Minister Harpal Cheema has announced the successful completion of the allotment process for 207 retail excise groups for 2025-26. The process, which commenced on March 5 and concluded on April 2, has generated an annual licence fee of Rs 9,878 crore, surpassing the projected target of Rs 9,017 crore. This represents a 9.5 per cent rise over the set reserve price. Revealing this in a press release here, Cheema said the excise department had allotted 207 retail groups successfully through online auction and the process saw a good response. Emphasising that the total excise revenue for 2025-26 is set to cross Rs 11,500 crore, the minister said the excise department's consistent year-on-year success is a direct result of strategic policy formulation. He said the state's excise policy ensured the availability of high-quality liquor at competitive prices. Cheema commended the efforts of excise officials in combating the illicit liquor trade and smuggling. He said the excise department remained steadfast in its mission to enhance revenue generation while upholding regulatory integrity and consumer welfare.

BJP'S POLITICS DEPENDS ON 'PAKISTAN, MUSALMAN, AND KHALISTAN': SAD MP HARSIMRAT BADAL

Diary Times Desk : Shiromani Akali Dal (SAD) leader Harsimrat Kaur Badal accused BJP of communal politics and said that the saffron party's entire politics depends on only three things – Pakistan, Musalman, and Khalistan. "The party whose entire politics is based on Hindu-Muslim polarisation...whose entire politics is based on Pakistan, Musalman, and Khalistan... How come they suddenly thought of judiciously utilising Muslims' money," Badal said in the Lok Sabha during the discussion on the Waqf (Amendment) Bill. The Lok Sabha passed the bill with a 288-232 vote in the wee hours of Thursday after a 12-hour debate. Union Minority Affairs Minister Kiren Rijiju tabled the Waqf (Amendment) Bill, 2025, today in the Rajya Sabha. Badal accused BJP of not having a single Muslim MP in the Lok Sabha while the 24 parliamentarians, all in opposition, are against the amendment bill. "When I tried to find information on the politics behind introducing this bill, I came across a paper on Waqf asset management that revealed 27 per cent of Waqf land is in Uttar Pradesh, where elections are scheduled to take place within the next year-and-a-half," the MP said. Badal stated that if the government is genuinely concerned about the welfare of minority communities, it should consider amending Article 25B of the Constitution. "The Sikhs, a minority community, have long demanded.

HARYANA TO UPGRADE FIRE SERVICES WITH 250 NEW VEHICLES AND 13 HYDRAULIC PLATFORMS

Diary Times Desk : The Fire and Emergency Services Department of the Haryana Government is set for a major upgrade with the procurement of 250 new firefighting vehicles and 13 hydraulic platforms proposed for the 2025-26 financial year. Additionally, Rs 29 crore will be spent on establishing a state-level fire training institute over 25 acres in Kheri Masania village of Jind district, as announced bv Financial Commissioner Revenue (FCR) Sumita Misra Currently. the department has 504 fire vehicles of various categories and 202 motorcycles with fire equipment available in different fire stations. The fire department merged with the Revenue and Disaster Management Department on January 1, 2023. To provide timely and proper fire emergency services, 3,776 posts of various categories have been sanctioned. These include 43 posts for the Directorate of Fire and Emergency Services, Haryana; 24 posts for the Fire Training Centre, Manesar; and 3,709 posts for various fire stations. Presently, 109 fire stations are functional in the state, with four newly created stations.

POWER SHOCK: CONSUMERS TO PAY UP TO 30 PAISE MORE PER UNIT

Diary Times Desk : Electricity in the state will now cost more as the Electricity Regulatory Harvana Commission (HERC) has revised the tariff from April 1. The rates will increase for both domestic and industrial categories from 20 to 30 paise per unit - technically called kWh (kilowatt hours). The tariff for domestic consumers has been hiked by 20 paise per kWh. In a slab of 0 to 50 units, the rate has now been revised from Rs 2 per kWh to Rs 2.20 per kWh. The tariff order was released late on Tuesday night. In the 51-100 unit slab, the rate has been increased from Rs 2.50 per kWh to Rs 2.70 per kWh. Consumers with consumption of over 100 units a month (in the slab of 0-150 units) will pay Rs 2.95 per kWh, up from Rs 2.75. "Further, this new tariff structure delivers immediate relief to households by eliminating the Minimum burden of Monthly Charges (MMC). However, a twopart tariff regime has been introduced in which no fixed charges will be levied on domestic consumers having monthly energy consumption up to 300 units. The tariff for Category-I domestic consumers is still one of the lowest among the neighbouring states.

APPLE GROWERS SLAM HPMC FOR RENTING ITS CA STORES, GRADING & PACKING LINES

Diary Times Desk: The decision of the Horticulture Produce Marketing and Processing Corporation (HPMC) to rent its assets like controlled atmosphere (CA) stores and grading and packing lines has not gone down well with apple growers. They have termed the corporation's decision as antifruit growers that will lead to monopoly of private players in the sector and increase in the storage and grading and packing costs for growers. "The will private players he concerned about maximizing their profits not the welfare of the growers. If there's no provision for capping the prices of services at these facilities, it will lead to an overall increase in the storage and grading and packing costs," said Lokinder president Risht of the Progressive Growers Association. Sohan Thakur, president of the Seb Utpadak questioned Sangh, the corporation's haste in renting these facilities to private players. "Most of these facilities have become operational only over the past couple of years. Instead of renting these facilities to private parties, why can't the HPMC make efforts to make these sustainable?" he asked.

WAQF BILL BASED ON RECOMMENDATIONS OF 2006 PANEL: BINDAL

Diary Times Desk : State BJP president Rajeev Bindal todav said that the Waaf Amendment Bill was based on the recommendations of a committee set up in 2006 to look into reforms required in the law. In a statement issued here, Bindal said that the proposed amendment Bill should be looked at objectively as it was for the betterment of the Waqf Board. "A committee set up in 2006 had presented a report recommending reforms, which were never undertaken," he added. Bindal said, "The Sachar Committee gave its report in 2006 and after that a Joint Parliamentary Committee presented its report in 2008. It was found that there were huge encroachments on the properties and land of the Waqf Board and its income was continuously on the decline." He said that in 2013, the then Congress government.

CENTRE APPROVES RS 267 CRORE BOOST FOR VARIOUS ROAD PROJECTS IN HIMACHAL: VIKRAMADITYA

Diary Times Desk : Public Works Minister Vikramaditya Singh announced today that the Union Government has sanctioned Rs 267 crore for various projects in Himachal Pradesh, including national highways. The state had submitted a total capital expenditure request of Rs 1,400 crore for the financial year 2025-26, and Rs 267 crore has been released in the first phase. Singh expressed his gratitude to Union Minister for Road Transport and Highways Nitin Gadkari for sanctioning the funds. He had personally raised the matter with Gadkari on multiple occasions to expedite approvals and fund allocations. He said the alignment work for the Jalori Jot tunnel has been completed, and a detailed project report worth Rs 1,452 crore is being prepared. The tunnel will have a total length of 4.156 km and is expected to be finalised within this financial year. He added that the approved projects include the construction of three bridges each in Chamba and Una districts. Additionally, Rs 54.37 crore has been allocated for landslide mitigation on the Nigulsari-Nathpa road, and Rs 40.85 crore for landslide mitigation near the Keru bridge on the Katori Bangra-Banikhet-Chamba-Bharmour road.

GOVT RAISES RS 900-CRORE LOAN FOR DEVELOPMENT, FIRST IN 2025-26

Diary Times Desk : The Himachal Government has raised a loan of Rs 900 crore in new financial year 2025-26 to meet its development needs. The Finance Department had yesterday issued the notification for raising the loan, the first in this financial year, which would be repaid after 10 years by April 4, 2035. The government has cited the objective of using the amount for its development programme for raising the loan. It had sought the consent of the Central Government before applying for the loan, as required under Article 293(3) of the Constitution. Besides requiring money for development, the biggest committed liability of the state government is the bill of salaries and pension of its employees. The government in 2024-25 had raised loans to the tune of Rs 29,046 crore. Chief Minister Sukhvinder Singh Sukhu had stated that of Rs 29,046 crore, only Rs 8,693 crore was spent on development and the rest of the money went towards the repayment of the past debt and interest component on the loans raised by the previous BJP government. The annual financial liability of the salaries and pension of serving and retired government employees works out to be about Rs 30,000 crore. The current financial year is likely to be tough for the state government, as the revenue deficit grant (RDG) will come down to Rs 3,257 crore.



CLAIMS UNDER FOREST RIGHTS ACT TO BE SETTLED IN TIME-BOUND MANNER: REVENUE MINISTER NEGI

Diary Times Desk : Directions have been issued for the settlement of claims under the Forest Rights Act, 2006, in a time-bound manner, said Revenue Minister Jagat Singh Negi in an exclusive interview with The Tribune in Dharamsala today. Negi said that directions had been issued that the subdivisional level committees (SDLC) and the district level committees (DLCs) formed in the state should settle claims submitted by people within two weeks. "Gram sabhas should settle the claims of people within a month. The government will honour officials who settle the claims of people under the Forest Rights Act, 2006, within a stipulated time while the officials who delay the clearance of claims will be punished," he added. The minister said that many people had an impression that the Forest Rights Act, 2006, was applicable to tribal areas only. However, any person who could prove that he was using forestland traditionally through generations till 2005 could claim its title under the law. Once the title of the forestland under the Forest Rights Act, 2006, was issued to people, they could use and even build houses on it, he added.

POLLUTING INDUSTRIES IN BADDI BAROTIWALA NALAGARH INDUSTRIAL AREA FACE RS 3.2 CRORE PENALTY

Diary Times Desk : In a bid to improve the air and water quality of the Baddi Barotiwala Nalagarh (BBN) industrial area, the State Pollution Control Board has collected an environmental compensation of Rs 3.2 crore in the last five years. The compensation is levied on units that violate environmental pollution norms, in line with the National Green Tribunal's (NGT) directive, which follows the "polluter pays" principle. The amount highlights the negligence of industrial units that violate environmental standards to avoid spending on pollution control measures, thereby evading their social responsibility. From 2019 to 2024, as many as 87 of the 2,919 industrial units in BBN were found violating various pollution control norms. As a consequence, they were fined Rs 3.2 crore, according to a reply provided by the State Pollution Control Board in the recent budget session of the Vidhan Sabha in response to a query from Nalagarh MLA Hardeep Bawa. The BBN industrial area houses 380 red category firms, 1,404 orange category firms, and 1,135 green category firms. Red category industries, such as cement manufacturers, distilleries, and metal extraction units, have the highest pollution potential and are required to adopt stringent environmental controls. Orange category industries, which include bottling of gases and ice cream manufacturing, require moderate pollution control measures, while green category industries, like food processing, bakery and handloom units, have a lower environmental impact and face fewer regulatory requirements.

KKR VS SRH HIGHLIGHTS, IPL 2025: V3 OF KKR SHINES AS DEFENDING CHAMPIONS THRASH SRH BY 80 RUNS

IPL 2025: FOCUS ON STARS AS HARDIK PANDYA'S MUMBAI INDIANS TAKE ON RISHABH PANTS LSG

Diary Times Desk : Five-time champions Mumbai Indians (MI) take on Lucknow Super Giants (LSG) in the Indian Premier League (IPL) 2025 in Match 16 on Friday, with all eyes on ex-MI skipper Rohit Sharma and LSG captain Rishabh Pant, as both India stars have failed to impress with the bat so far. The Hardik Pandya-led Mumbai Indians, however, are struggling for form, as they managed to get just one win in three outings and are sitting fifth in the points table. After two losses in a row, MI finally registered their first win when they secured an eight-wicket victory over defending champions Kolkata Knight Riders on Monday. The biggest concern for the Mumbai-based outfit is ex-skipper Rohit Sharma's form. The opener is yet to show his magic in the tournament, as he registered a series of low scores (0, 8, and 13), which is his worst IPL start since 2020. Besides Rohit's form, uncertainty over the availability of their premier pacer Jasprit Bumrah is another major concern for the hosts. Reports are suggesting that Bumrah, who is currently undergoing rehab at the BCCI's Centre of Excellence (formerly the National Cricket Academy) in Bengaluru for a lower back injury, is not returning to action anytime soon. However, Ryan Rickelton came out as one of the positives.

PAKISTAN FINED FOR SLOW OVER-RATE FOR THIRD TIME IN FOUR ODIS

Diary Times Desk : Pakistan incurred an over-rate offence for a second game in a row against New Zealand after they were found one over short in the second ODI in Hamilton. The players were fined 5% of their match fees after captain Mohammad Rizwan pleaded guilty to the offence. Match referee Jeff Crowe imposed the sanction as per Article 2.22 of the ICC Code of Conduct, which governs over-rate offences. Players are fined 5% of their match fees for each over the team falls short of bowling in the given time. Pakistan were found two overs short in the opening ODI of the three-game series in Napier, where they lost by 73 runs. This was after New Zealand wicketkeeper Mitchell Hay scored an unbeaten 99 to help them post 292, and that was followed by fast bowler Ben Sears registering his ODI-best figures of 5 for 59. Pakistan were also fined for a slow over-rate in the opening match of the 2025 Champions Trophy.

GUJARAT TITANS PACER KAGISO RABADA RETURNS HOME FROM IPL DUE TO...

The Titans, though, have not specified the duration of Rabada's absence from the IPL 2025, where he has played two matches. "Kagiso Rabada has returned to South Africa to deal with an important personal matter," the Gujarat outfit said in a statement. Rabada appeared against Punjab Kings and Mumbai Indians, grabbing 1 for 41 and 1 for 42 respectively in those matches. The 29-year-old was not picked for Gujarat Titans' match against Royal Challengers Bengaluru at the M Chinnaswamy Stadium on Wednesday. Arshad Khan was drafted into the eleven in place of Rabada, and the left-arm pacer picked up the key wicket of Virat Kohli early in the innings. In the absence of Rabada, GT could be relying on his South African teammate Gerald Coetzee or Afghanistan all-rounder Karim Janat.
