Diary Times Desk: Amid allegations of voter fraud in the 2024 Lok Sabha election by the Opposition, the Election Commission of India on Saturday said that the appropriate time to e any issue with the electoral rolls was during the "Claims and Objections" period ahead

"Recently, some Political Parties and individuals are raising issues about errors in Electoral Rolls, including the Electoral Rolls prepared in the past," the Election Commission said in a press release on Saturday.

"The appropriate time to raise any issue with the Electoral Rolls would have been during the Claims and Objections period of that phase, which is precisely the objective behind sharing the Electoral Rolls with all Political Parties and the Candidates. Had these issues been raised at the right time through the right channels, it would have enabled the concerned SDM / EROs to correct the mistakes, if genuine, before those elections," it added

The poll body said that after the publication of the draft electoral rolls, its digital and physical copies are shared with all political parties and put on the ECI websit

"Following the publication of the draft ER, a full one-month period is available with the Electors and Political Parties for the filing of Claims and Objections before the final ER is published," the Election Commission said.

"After the publication of the final ER, digital and physical copies are again shared with all the recognised Political Parties and published on the ECI website," it added. The Election Commission of India said that utmost transparency remains as the hallmark of electoral roll preparation as per law, rules and guidelines. It also mentioned that "some political parties" and their booth level agents (BLAs) failed to review the electoral rolls timely and did not highlight any errors.

"Those who conspire will not back down, they will try to steal votes.. The way the game of adding and deleting fake votes was being played, BJP people have been caught red-handed. Now even ordinary citizens are providing evidence of vote theft...Today, the right to vote is being taken away from Dalits, the deprived, the oppressed, the exploited, and minorities; tomorrow, their participation will be taken away. A conspiracy was being hatched to attack the poor sections of this country, against which the people of the country have raised their voices," Congress' media and publicity department chairman Pawan Khera said at a press conference in Delhi

According to the Congress, the Yatra will start from Sasaram in Bihar and cover 1,300 km across the state in 16 days. It will conclude in Patna with a public rally attended by leaders of the INDIA

Taking aim at the Election Commission, Khera alleged that the institution was functioning as "just a compartment of this double engine" and vowed continued resistance. "MAYBE I WON'T HAVE TO DO IT": TRUMP ON 25% INDIA TARIFF OVER RUSSIAN



Diary Times Desk: US President Donald Trump on Friday claimed Russia lost India as one of its oil clients after Washington announced a penalty on New Delhi over the purchases, but indicated he may not impose such secondary tariffs countries continuing to procure Russian

The President's remarks came even as New Delhi is yet to confirm any halt in oil purchases from Moscow after Washington announced a 25 per cent duty in addition to a 25 per cent tariffs on Indian goods last month. The additional duty is scheduled to come into effect on August 27.

The US had threatened sanctions on Moscow and secondary sanctions on countries that buy its oil if no moves are made to end the war in Ukraine. China and India are the top two buyers of Russian oil.

"Well, he (Russian President Vladimir Putin) lost an oil client, so to speak, which is India, which was doing about 40 per cent of the oil. China, as you know, is doing a lot...And if I did what's called a secondary sanction, or a secondary tariff, it would be very devastating from their standpoint. If I have to do it, I'll do it. Maybe I won't have to do it," Mr Trump told Fox News as he departed for Alaska for a high-stakes meeting with his Russian counterpart Vladimir Putin.

On August 6, Mr Trump escalated his tariff offensive against India by slapping an additional 25 per cent duty and subsequently doubling it to 50 per cent on Indian goods over New Delhi's continuous imports of Russian oil. India condemned the "unfair, unjustified and unreasonable" move that is likely to hit sectors such as textiles, marine and leather exports hard.

NCERT BLAMES JINNAH, CONGRESS, MOUNTBATTEN AS "CULPRITS OF PARTITION"



Diary Times Desk: A new special module by the National Council of Education Research and Training (NCERT) has blamed three figures as responsible for the Partition of India, including Muhammad Ali Jinnah, the Congress leadership, and then Viceroy Lord Mountbatten. The module, created for 'Partition Horrors Remembrance Day', observed every year on August 14, states, "Jinnah, who demanded it; second, the Congress, which accepted it; and third, Mountbatten, who implemented it."

This reference appears in a section titled 'Culprits of the Partition' in the module designed for Classes 6 to 8. Alongside, it also carries a speech by Jawaharlal Nehru from July 1947, which reads, "We have come to a stage when we must either accept division or face continued conflict and chaos. Partition is bad. But whatever the price of unity, the price of civil war would be infinitely greater."

NCERT has published two separate modules-one for Classes 6 to 8 (middle stage) and another for Classes 9 to 12 (secondary stage). These are supplementary resources in English and Hindi, not part of regular textbooks, and are meant to be used through projects, posters, discussions and debates. Both modules open with Prime Minister Narendra Modi's 2021 message announcing the observance of Partition Horrors Remembrance Day, Quoting his post on X (formerly Twitter), the book mentions, "Partition's pains can never be forgotten. Millions of our sisters and brothers were displaced, and many lost their lives due to mindless hate and violence. In memory of the struggles and sacrifices of our people.

CENTRE WARNS OF "CONSTITUTIONAL CHAOS" AFTER TIMELINE ORDER FOR GOVERNORS



Diary Times Desk: The government has warned against imposing a timeline on the President and Governors for clearing bills, with an earlier Supreme Court order. A bench of Justices JB Pardiwala and R Mahadevan had in April prescribed a three-month deadline for the President and one month for Governors to decide on the bills passed by the legislature.

Such timelines would amount to an organ of the government usurping powers that are not vested in it, thereby upsetting the delicate separation of powers, the government said in a written submission to the top court, warning that it will lead to "constitutional

"Even under its extraordinary powers vested in Article 142, the Supreme Court cannot amend the Constitution or defeat the intent of the Constitution makers, provided there are no such procedural mandates in the constitutional text," Solicitor General Tushar Mehta said in his submission

Though there may be "some limited problems in implementation" of the assent process, these cannot justify "reducing the higher office of the Governor to a subordinate one," said Mr Mehta. He argued that the the Governor to a subordinate one," said Mr Mehta. He argued that the offices of the Governor and President are "politically complete" and represent "higher ideals of democratic governance". Any alleged lapses should be redressed through political and constitutional mechanisms, not through "unwarranted judicial" interventions, he said. Under Article 200 of the Constitution, the Governor can give assent to the bills presented to him by the legislature, withhold or reserve it for the consideration of the President. He can also send it back to the House for reconsideration. back to the House for reconsideration.

INDIGO AIRCRAFT'S TAIL HITS RUNWAY DURING GO-AROUND AT MUMBAI AIRPORT



Diary Times Desk : An IndiGo Airbus A321 aircraft's tail touched the runway while powering up for a go-around manoeuvre in low altitude due to bad weather in Mumbai on Saturday, the airline said.

Giving details of the incident, an IndiGo spokesperson said, "On August 16, 2025, an IndiGo Airbus A321 aircraft tail touched the runway while executing a low-altitude go-around due to unfavourable weather conditions in Mumbai. Thereafter, the aircraft carried out another approach and landed safely." Stating that it is following all safety protocols, Indigo said it will "following the standard protocol and the aircraft will go through necessary checks/ repairs and regulatory clearance before resuming operations. "At IndiGo, the safety of our customers, crew, and aircraft is our top priority. OVER 350 DELAYS, 15 GO-AROUNDS, 2 DIVERSIONS: FLIGHT OPERATIONS HIT IN MUMBAI AMID HEAVY RAIN

AS 'MASS BURIAL' PROBE HITS DEAD ENDS, OPPN SLAMS SIDDARAMAIAH GOVT OVER DHARMASTHALA 'SMEAR CAMPAIGN'

Diary Times Desk: After nearly a month of excavations and other inquiries, the Special Investigation Team (SIT) probing allegations of mass burials in Karnataka's Dharmasthala is yet to find any credible evidence to substantiate a former temple worker's claims of murder, rape and torture victims having been secretly buried there, ThePrint has learnt.

According to people directly aware of the probe, the startling claims and so-called evidence submitted before the authorities by the former sanitation worker have "failed" to support the allegations so far.

"The human skeletal remains he presented before the court were that of a male. The other skeletal remains we found during excavation and near the identified sites, are that of males. He had claimed that the remains which he exhumed before approaching the police, were that of a woman who was supposedly a victim of sexual assault.

'OLD RHETORIC': OPPOSITION HITS BACK AT MODI'S I-DAY SPEECH

Diary Times Desk: Congress president Mallikarjun Kharge on Friday accused the Bharatiya Janata Party (BJP) of filling constitutional bodies with "people of its ideology", and claimed that the ruling party can go to the extent of immorality to remain in power.

Hoisting the Tricolour in Indira Bhavan — the Congress's new central office — for the first time, Kharge further reminded the opposition party that the fight over alleged manipulation of voter lists is not for winning elections but to save democracy.

"The ruling party has filled the constitutional institutions with people of its ideology instead of merit. Whenever they wanted, they appointed anyone, and whenever they wanted, they took their resignation," he said in his address.

Kharge invoked the history of India's freedom movement and said the story of the freedom struggle is "the story of our party".

Attacking the Election Commission of India (ECI) and the BJP over the ongoing special intensive revision (SIR) of electoral rolls in poll-bound Bihar, Kharge quoted BR Ambedkar, saying "Franchise is one of the most fundamental things in a democracy. No person who is entitled to be brought into the electoral rolls... should be excluded merely as a result of prejudice..."

"But now the ruling party is ready to go to the extent of immorality to remain in power. Large scale irregularities are coming to the fore in the elections. In the name of SIR, the votes of the opposition are being openly cut. Those who are alive have been made dead," Kharge said.

MEXICAN STATE ACCUSES ADIDAS OF CULTURAL APPROPRIATION OVER NEW SHOE, THREATENS LEGAL ACTION



Diary Times Desk: The Mexican state of Oaxaca is threatening legal action against Adidas, accusing the footwear company of cultural appropriation over a newly unveiled shoe that resembles a traditional handmade sandal

The "Oaxaca Slip-On," billed as a collaboration between American designer Willy Chavarria and Adidas Originals, features a woven leather surface, open heel, and thick rubber sole – and, in the eyes of the Oaxaca government, bears more than a passing resemblance to the "huarache" handmade sandal from the Oaxacan community of Villa Hidalgo Yalalag. Oaxacan Governor Salomón Jara Cruz on Wednesday accused the company of copying the Yalalag design without asking permission or crediting the community. He also demanded that Adidas withdraw the shoe, engage in talks with the Indigenous community and publicly recognize the Yalalag as the originators of the design.

"This is not just a design, it is about the culture, history and identity of an original (people) and we will not allow it to be treated as merchandise," he said in a video posted on X. He pledged "legal support" for Villa Hidalgo Yalalag, and said he had already spoken with members of the community about taking action against the footwear company.

Adidas did not immediately respond to a CNN request for comment. Neither has it issued a public statement addressing the controversy. One option for the Oaxacan government would be to file a formal complaint with the Instituto Mexicano de la Propiedad Industrial (IMPI), Mexico's federal agency for intellectual property protection.

FORMER COLOMBIAN PRESIDENT ÁLVARO URIBE SENTENCED TO 12 YEARS OF HOUSE ARREST

Diary Times Desk: Former Colombian President Álvaro Uribe was sentenced Friday to 12 years of house arrest after being found guilty of procedural fraud and witness bribery.

Uribe had pleaded not guilty. His defense attorney previously announced that they would file an appeal. Judge Sandra Heredia of Bogotá's 44th Criminal Court announced the sentence four days after she found the former president guilty of the crimes. Heredia had acquitted Uribe of another charge for alleged bribery of a prosecutor.

Uribe, 73, who governed Colombia from 2002 to 2010, is the country's first former president to be criminally convicted.

The case began in 2012, when Uribe, of the nowopposition Centro Democrático party, accused Senator Iván Cepeda, of the ruling Historic Pact, of trying to link him to the creation of a paramilitary group. Cepeda has denied the accusations.

The situation took a turn in 2018, when the Colombian Supreme Court decided to open an investigation against Uribe for alleged witness tampering.

TRUMP'S MAJOR CHINA GAMBLE HAS PAID OFF SO FAR. BUT XI STILL HOLDS TRUMP CARDS



Diary Times Desk: President Donald Trump has placed a massive bet that the United States can take an historically aggressive stance against China, the world's second-largest economy, and emerge stronger because of it.

Although it remains unclear if the gamble will pay off over the long term, Trump has been riding an incredible winning streak in recent months. The stock market is near record highs, the US economy rebounded in the second quarter and inflation has defied predictions of a surge after Trump put his tariffs in action.

But Chinese leader Xi Jinping is on a winning streak of his own. On Monday, Trump opened the door to sending China faster Al chips after releasing previously blockaded mid-tier chips. And despite America's tariffs, China has successfully found other markets to sell to, flooding the world with its goods.

ISRAEL'S NETANYAHU HAS 'LOST THE PLOT,' NEW ZEALAND LEADER LUXON SAYS

Diary Times Desk: New Zealand Prime Minister Christopher Luxon said Wednesday that his Israeli counterpart Benjamin Netanyahu has "lost the plot" and that Israel's planned occupation of Gaza City is "utterly unacceptable."

Luxon's comments come as his conservative coalition government weighs whether to join other members of the Five-Eyes security alliance, Australia, Britain and Canada, in moving to recognize a Palestinian state; and as international condemnation and anger builds over Israel's recent decision to expand its war to take control of Gaza City, the throttling of aid and mass starvation in the enclave.

Luxon, who leads the right-leaning National Party, said Netanyahu is "not listening" to the international community's demands for "unfettered" humanitarian aid to be delivered to Gaza.

"I think Netanyahu has gone too far. I think he has lost the plot. And I think what we are seeing overnight with the attack on Gaza City is utterly, utterly unacceptable," Luxon said, in some of his strongest comments against Israel's actions in Gaza to date



US AND MEXICO AGREE TO LONG-TERM WASTEWATER TREATMENT PLAN IN THE SAN DIEGO-TIJUANA REGION

Diary Times Desk:

The governments of Mexico and the United States signed a memorandum of understanding on Thursday to fund and expedite several wastewater treatment projects in the Tijuana River basin.

Untreated wastewater continually affects residents living along the river, which flows across the border from Tijuana and through several of San Diego's southern neighborhoods. Residents living along the river have long battled severe health issues which researchers say stem from the river's contamination.

One research team based at the University of California San Diego found that trace amounts of waterborne chemicals from tires, personal care products, and even illicit drugs present in the Tijuana River are being introduced into the air — exacerbating health concerns for tens of thousands of residents living on its banks.

In Thursday's event celebrated in Mexico City, US Environmental Protection Agency Secretary Lee Zeldin and Mexico's Secretary of the Environment and National Resources of Mexico Alicia Bárcena agreed to a series of actions to be taken by both governments by 2027 to address the deteriorating wastewater treatment crisis.

CHINESE 'OVERKILL' IN DISPUTE WITH PHILIPPINES DAMAGED TWO CHINESE SHIPS. WHY IT COULD HAVE BEEN MUCH WORSE

It's hard to call the collision of two multi-thousand-ton military ships "fortunate," but that's exactly what analysts are saying about the incident in the South China Sea this week that left a China Coast Guard ship with a heavily damaged bow after it hit a People's Liberation Army Navy guided-missile destroyer.

Dramatic footage released by the Philippine Coast Guard showed the moment the collision took place, leaving the China Coast Guard ship missing a prominent part of its bow. Commodore Jay Tarriela of the Philippine Coast Guard said the incident occurred on Monday while personnel were distributing aid to Filipino fishermen near the disputed Scarborough Shoal, approximately 140 miles west of the Philippine island of Luzon. Tarriela said a China Coast Guard vessel was chasing the Philippine Coast Guard vessel.

'IF ALL WORKS OUT...': DONALD TRUMP ON MEETING WITH UKRAINE'S ZELENSKY ON MONDAY

Diary Times Desk: US President Donald Trump on Saturday said he will host Ukrainian President Volodymyr Zelensky at the Oval Office in Washington on Monday, days after his summit with Russian President Vladimir Putin in Alaska ended without a breakthrough on Ukraine.

"President Zelenskyy will be coming to D.C., Oval Office, on Monday afternoon," Trump posted on Truth Social. He added, "If all works out, we will then schedule a meeting with President Putin."

"The best way to end the horrific war between Russia and Ukraine is to go directly to a Peace Agreement, which would end the war, and not a mere Ceasefire Agreement," he said



MEXICAN PROSECUTOR KILLED IN DRIVE-BY SHOOTING CAUGHT ON FILM

Diary Times Desk: A federal prosecutor in Mexico has been killed in a drive-by shooting that has shocked the nation after video footage of the attack circulated online.

The footage shows the prosecutor sitting on a road in the border city of Reynosa, Tamaulipas state, shortly after his car has caught fire. A white vehicle then drives past and the sound of multiple gunshots rings out. The prosecutor falls to the ground and then lies motionless. It's not clear what caused the fire.

The Mexican Attorney General's Office has identified the killed man as Ernesto Cuitláhuac Vásquez Reyna, who worked in the state of Tamaulipas.

It said the attack on Monday was still being investigated, but preliminary information suggested it may have been linked to organized crime gangs who had been recently targeted by authorities.

It pointed to the seizure by security forces of more than 1.8 million liters of stolen fuel in a bust last month as being among the main lines of investigation. Mexican President Claudia Sheinbaum said Tuesday that her security cabinet was in touch with state and federal prosecutors to "do justice in this case."

TRUMP DOUBLES REWARD TO \$50 MILLION FOR ARREST OF VENEZUELA'S PRESIDENT TO FACE US DRUG CHARGES

Diary Times Desk: The Trump administration is doubling to \$50 million a reward for the arrest of Venezuela's President Nicolás Maduro, accusing him of being one of the world's largest narcotraffickers and working with cartels to flood the US with fentanyl-laced cocaine.

"Under President Trump's leadership, Maduro will not escape justice and he will be held accountable for his despicable crimes," Attorney General Pam Bondi said Thursday in a video announcing the reward.

Maduro was indicted in Manhattan federal court in 2020, during the first Trump presidency, along with several close allies on federal charges of narcoterrorism and conspiracy to import cocaine. At the time, the US offered a \$15 million reward for his arrest. That was later raised by the Biden administration to \$25 million — the same amount the US offered for the capture of Osama bin Laden following the September 11, 2001, attacks.

Despite the big bounty, Maduro remains entrenched after defying the US, the European Union and several Latin American governments who condemned his 2024 reelection as a sham and recognized his opponent as Venezuela's duly elected president.

US CONDEMNS BRAZIL SUPREME COURT ORDER FOR HOUSE ARREST FOR EX-PRESIDENT JAIR BOLSONARO

Diary Times Desk: The US State Department has condemned a Brazilian Supreme Court order for the house arrest of former President Jair Bolsonaro, who is on trial over an alleged plot to overturn the results of the 2022 presidential election.

Justice Alexandre de Moraes issued the order Monday, saying Bolsonaro had failed to comply with restrictions previously imposed on him by the court, including use of social media and cell phones.

The court decision comes at a time of tense relations between Washington and Brasilia, with the case against right-wing populist Bolsonaro being seized on by US President Donald Trump as a threat in trade negotiations.

On Monday, the US State Department's Bureau of Western Hemisphere Affairs accused Justice Moraes of using "Brazil's institutions to silence opposition and threaten democracy," in a post on X.

"Putting even more restrictions on Jair Bolsonaro's ability to defend himself in public is not a public service. Let Bolsonaro speak!," said the post.



US TRADE TEAM'S INDIA VISIT CALLED OFF, LIKELY TO BE RESCHEDULED: SOURCES

Diary Times Desk: Amid a strain in economic ties because of the increased tariff, a planned visit by a US team to India for trade negotiations from August 25 to 29 has been cancelled and is likely to be rescheduled, sources told NDTV Profit on Saturday.

The team was supposed to carry forward negotiations on the bilateral trade agreement between the countries, which is especially important now, given US President Donald Trump's announcement of a 25% levy on Indian goods over Russian oil imports, in addition to the 25% tariffs he had imposed before.

The negotiations would have been the sixth round of talks between the US and India on the bilateral trade agreement and their timing was also crucial because they would have been held around August 27, when the additional 25% tariff is scheduled to take effect. They were also being held ahead of the fall, or September-October timeframe, that was being targeted for the finalisation of the agreement.

Diary Times Desk: The United States' military might was on full display on Friday at Alaska when a B-2 Spirit Stealth Bomber flanked by US fighter jets thundered across the sky above Russian President Vladimir Putin, as he met President Donald Trump for a high-stakes meeting on the Ukraine conflict.

The B-2 is capable of entering sophisticated air defenses and delivering precision strikes against hardened targets, as they did in June when the US forces bombarded Iranian nuclear sites.

'NUMBER 1 IS LIVES': TRUMP ON WHY HE MEDIATES TENSIONS: NAMES INDIA-PAK CONFLICT

Diary Times Desk: US President Donald Trump on Monday reiterated his claims of preventing wars across the globe, including between India defending Pakistan, while administration's push for ceasefires in conflicts that, as Fox News host Sean Hannity noted, "do not impact the United States as much as [they dol allies in Europe."

They were shooting down airplanes already. And that would have been maybe nuclear. I would have said it was gonna get nuclear, but I was able to get it done. Number one is lives, number two is everything else," Trump said.Trump said he had warned the two Southeast Asian nations that Washington would not pursue trade deals with them unless they agreed to halt fighting. "We got them settled in 24 hours," he added.

PUNJAB EDUCATION DEPARTMENT ISSUES GUIDELINES FOR SCHOOL ADMISSIONS UNDER EWS QUOTA

Diary Times Desk : The Punjab Education Department has issued guidelines for admission of EWS students in private schools, fixing 25 per cent quota for the disadvantaged children.

The department has issued standard operating procedure for EWS admissions in private schools, under the Right of Children to Free and Compulsory Education (RTE) Act, 2009. The instructions have been issued following directives from the Punjab and Haryana High Court.

According to these instructions, all private, unaided schools, except minority schools, would admit children belonging to the EWS and disadvantaged groups in nursery or LKG or UKG or Class I, whichever is the entry-level class of the school, to the extent of at least 25 per cent of the total seats as mandated by the RTE Act.

SUNNI WATERLOGGED AS SUTLEJ WATER LEVEL RISES



Diary Times Desk: Several areas of Sunni in Shimla district were waterlogged on Friday due to a rise in the water level of the Sutlej river, triggering panic among local residents.

According to reports, the Sutlej river swelled as a result of heavy rainfall, submerging a bridge that connects Thali village with Sunni. River water also entered the building of the Industrial Training Institute (ITI), a park and several houses near the river.

As a precautionary measure, houses near the reservoir were vacated and residents were shifted to safer places.

Rakesh Verma, Sub-Divisional Magistrate (SDM), said that the water is now receding but several areas of the town remain waterlogged.

He added that rehabilitation and restoration work is currently underway.

TWO DELHI TOURISTS KILLED BY SHOOTING STONE NEAR YULLA KANDA IN KINNAUR

Diary Times Desk: Two tourists from Delhi were killed after being hit by a shooting stone near Yulla Kanda in Himachal Pradesh's Kinnaur district, following a landslide triggered by heavy rainfall.

The deceased have been identified as Rashmi Ram (25) and Prasheel Baghmare (27), both residents of Delhi.

According to reports, the incident occurred while they were on their way to Lord Sri Krishna Temple at Yulla Kanda. They were caught in a landslide and hit by shooting stones, sustaining serious injuries and dying on the spot.

Police reached the spot as soon as it received the information and recovered the bodies. The deceased were taken to Civil Hospital, Bhawanagar, where post-mortem examinations were conducted.

Kinnaur Superintendent of Police (SP) Abhishek Shekhar confirmed the report, and said an investigation is underway.

313 ROADS REMAIN BLOCKED IN HIMACHAL AS HEAVY RAINFALL CONTINUES TO WREAK HAVOC

Diary Times Desk: Over 313 roads across the state remain disrupted for traffic movement as a result of being blocked due to torrential rains

As per the records of the State Emergency Operation Centre, as many as 175 roads in Mandi district, 64, including national Highway 305, in Kullu, 25 in Kangra, 12 in Chamba, 13 in Shimla, seven each in Una and Sirmaur, four in Lahaul and Spiti, three, including National Highway 5, in Kinnaur, two in Solan and one in Bilaspur district, remain blocked for vehicular movement.

As many as 348 distribution transformers — including 322 in Mandi, 11 in Kinnaur, seven in Kullu, six in Lahaul and Spiti and two in Chamba district — and 119 water supply schemes — including 44 in Mandi, 41 in Kangra, 11 in Shimla, nine in Kullu, seven in Chamba, three in Hamirpur and one in Solan district — also remain disrupted.

Meanwhile, heavy rainfall is very likely to continue in Himachal Pradesh as the State's Meteorological Department has issued yellow weather warnings for various districts till August 19. For August 17, a yellow alert has been issued for Shimla, Mandi, Kangra, Chamba and Sirmaur, resulting in heavy rainfall in isolated places of these districts.

Putin spelled out his demands for "land swaps" with Ukraine during his nearly three-hour summit with US President Donald Trump including vesterday, insistence Ukraine gives up the Donbas region eastern Ukraine, according to European officials familiar with Trump's accounting of the meeting to his counterparts afterward.

But he didn't back away from a demand to eliminate what Russia calls the "root causes" of the war in Ukraine - code for reducing size of Kyiv's military, the abandoning its aspirations to join NATO and becoming a neutral state.

The details of Putin's conditions emerged when Trump briefed European leaders on the talks as was arriving back in Washington early this morning. Trump said he believed a deal could be reached quickly if Putin's conditions were met, and that he would discuss the matter with Ukrainian President Volodymyr Zelensky at the White House on Monday, the officials said.

European leaders also said Trump voiced openness to providing US security guarantees for Ukraine once the war ends, though the specifics of what he's

"We will not leave Donbas. We cannot do this. Everyone forgets the first part—our territories are illegally occupied," Zelenskyy told reporters at the briefing on Tuesday. "Donbas for the Russians is a springboard for a future new offensive."

The comments come as US President Donald Trump and Russian President Vladimir Putin prepare to meet in Alaska on Friday It also comes as Russian forces on the ground have been closing in on a key territorial grab around the city of Pokrovsk.

On Tuesday, Zelenskyy diplomatic discussions led by the US, focusing on ending Moscow's war, have not touched on security guarantees for Ukraine to prevent future Russian aggression, and that meeting formats currently being discussed do not include Europe's participation, both key demands of Kviv.

Zelenskyy said the necessity of concessions conveyed to him by US officials ahead of Friday's summit in Alaska and in further meetings at the level of national security officials.

A call with Trump and special envoy Steve Witkoff after the latter's bilateral meeting with Putin gave more details about this, he said.

Witkoff reportedly told Zelenskyy that Russia was ready to end the war and that there should be territorial concessions from both sides. Some European partners were also part of the call.

Still, as his primary against Cornyn looms, Paxton has effectively silenced his Republican critics as the party waged a pressure campaign to return the absent House Democrats to Texas. And he did so using tools unavailable to Cornyn - who asked US Attorney General Pam Bondi to investigate the source of the Democrats' funding, but could not launch his own probe.

Paxton is "one of the most innovative AGs in terms of using his office for advancing his political vision," said Paul Nolette, a professor and the director of Marquette University's Les Aspin Center for Government who has written extensively about attorneys generals' use of their offices to influence national policy.

"What's new and unusual is that he's really been the one who has modeled how to use tools that don't, on their face, seem partisan, for greater partisan effect," Nolette said

Steve Vladeck, CNN Supreme Court analyst and professor at Georgetown University Law Center, said that among legal experts, "I think everyone views Paxton the same way — as someone who will stop at nothing to use and abuse his office to advance whatever he views as the partisan political imperative of the moment."

"He views himself less as the attorney general of Texas than as the attorney general of the Republican Party," Vladeck said. "And that may endear him to the folks who vote for him and who his actions benefit.

The match got underway with the crowd full of enthusiasm. In the 20th minute, in reflection of Jota's number, fans around the ground

stood, clapped in unison and chanted in honor of their muchloved forward.

As for the match itself, the Premier reianina League champions looked the part in a thrilling win featuring their dramatically changed roster.

Liverpool are favored to repeat as title-winners after bolstering the squad with multiple high-profile signings, including a trio from the Bundesliga: Florian Wirtz and Jeremie Frimpong from Bayern Leverkusen and Hugo Ekitike from Eintracht Frankfurt. New defender Milos Kerkez started as well and faced his former side on Friday.

U19 MEN'S CRICKET WORLD CUP: LINE-UP LOCKED IN FOR 2026 EDITION

Diary Times Desk: The line-up for the Under 19 Men's Cricket World Cup 2026 has been finalised, with USA becoming the 16th and final team to book tickets for Zimbabwe and Namibia.

Led by wicketkeeper-batter Arjun Mahesh, the Americans breezed through the double round-robin Qualifier on home soil in Rydal, Georgia and qualified with a game in hand to be played against Canada on 16 August.

Diary Times Desk: Chennai Super Kings have issued a clarification around the mid-season signing of South Africa's Dewald Brevis in IPL 2025, stating that the deal was "in complete compliance" with tournament regulations. The statement came after R Ashwin, speaking on his YouTube channel, suggested that the franchise had signed the 21-year-old for more than his eligible price of INR 2.2 crore.

"Dewald Brevis had a great time in the IPL last year after CSK got him in in the back half of the season," Ashwin said on his YouTube channel. "I even heard that two-three teams were also talking to him but they had to let him go after not being able to pay extra money. He had a base price in the auction but discussions and negotiations would have happened with his agent, that 'I'll join the team only for a certain sum of money'.

"His concept would have been that 'If I play this season, my value (for the next auction) will go higher.' So he might have told CSK, 'I'll need the extra money.' And the team was willing to pay him extra, which is why he came in," added Ashwin.

AFTER PANT INJURY, BCCI INTRODUCES 'SERIOUS INJURY REPLACEMENT' RULE



Diary Times Desk: The Board of Control for Cricket in India (BCCI) has amended the playing conditions and allowed injury replacements in multi-day cricket for the upcoming domestic season, an idea that has been in vogue since the recent Anderson-Tendulkar series in England.

"If a player sustains a serious injury during the course of the relevant match, a Serious Injury Replacement may be permitted in the following circumstances," the newly-introduced rule in the Playing Conditions states. "The serious injury must have been sustained during play and within the playing area described in clause."

The supposed rule change has led to a polarised opinion on the matter, with Ben Stokes calling it a ridiculous suggestion and Gautam Gambhir welcoming it. One player from each side – Rishabh Pant and Chris Woakes – suffered major injuries during the fourth and fifth Tests, rendering them unfit to continue in the Tests.

CLUTCH MAXWELL STEERS AUSSIES HOME IN FINAL-OVER THRILLER

Diary Times Desk: Glenn Maxwell has produced another piece of run-chasing brilliance to guide Australia to a series victory in the third BKT Tyres T201 against South Africa in Cairne.

Maxwell (62no from 36 balls, eight fours, two sixes) was the last recognised batter with 51 runs required from the final six overs, forced to turn down singles to shield the lower order from the strike.
